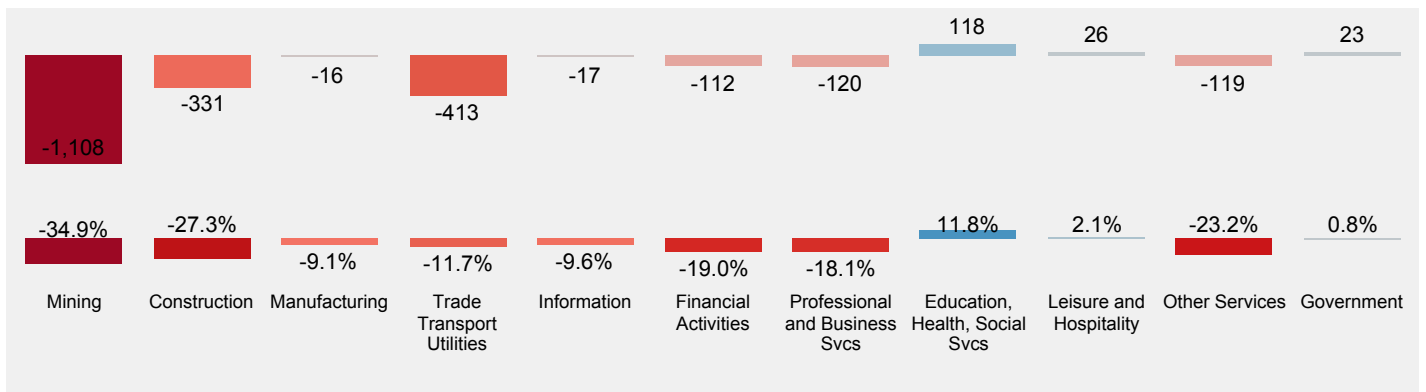
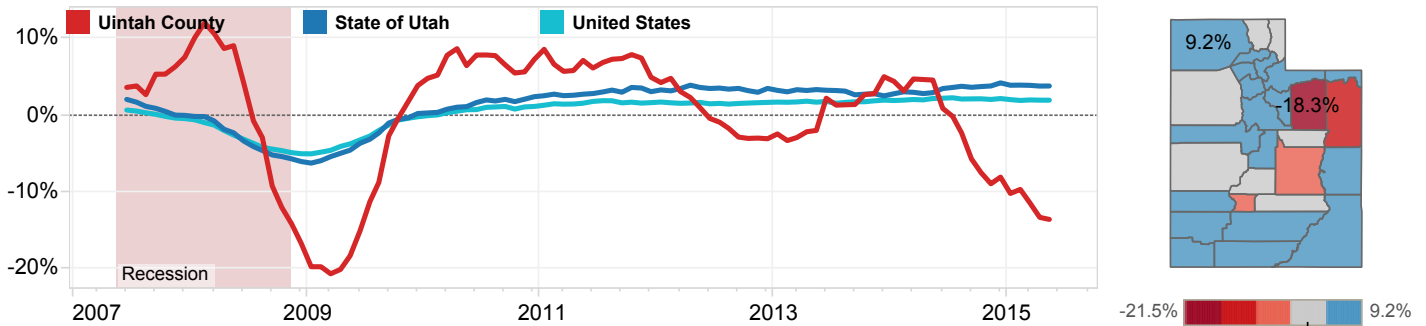
Year-to-Year Change in Nonfarm Jobs DECEMBER 2015*

How's the economy?

Currently, Uintah County's labor market shows the effects of a slumping energy market as jobs disappear in the mining industry. Not surprisingly, the loss of employment is reflected in a steeply rising unemployment rate. Construction permitting has also reacted to the commodity slump. Gross taxable sales mirrored the labor market slowdown with steep declines in all broadly defined sectors.

Jobs

Uintah County lost 2,069 jobs, or almost 13.5 percent of its base, between December 2014 and December 2015.

The damage created by the loss of 1,108 mining jobs, 331 construction jobs, and 413 transportation jobs could not be offset by gains in government and health/education services.

Other industries added to the general decline.

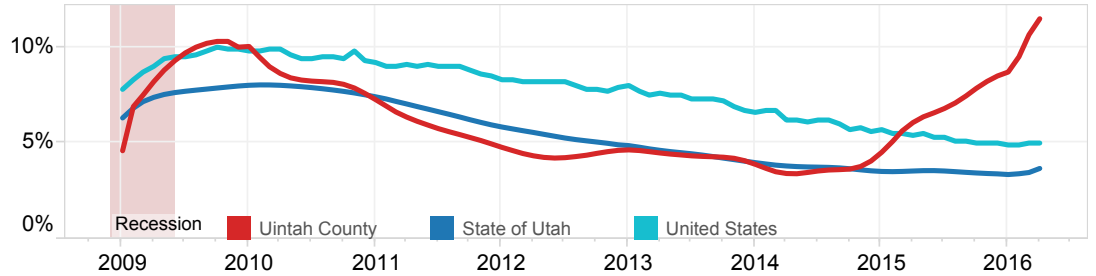
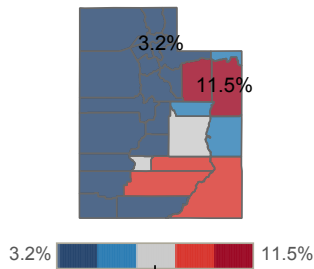


Seasonally Adjusted Unemployment Rate APRIL 2016

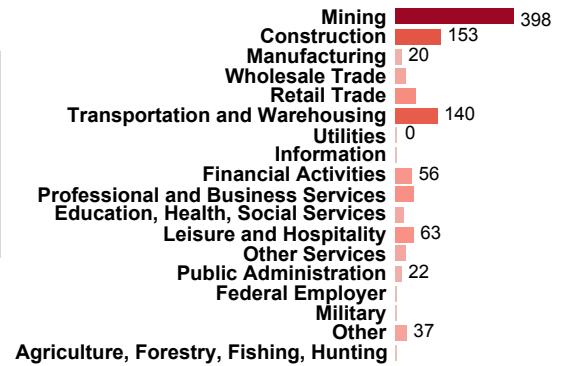
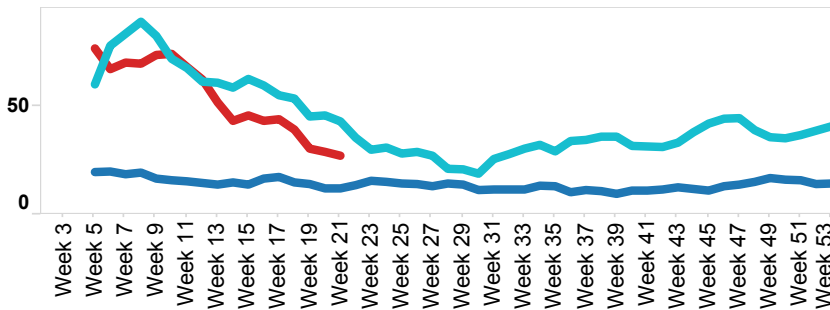


Initial Claims for Unemployment Insurance

Four-Week Moving Average

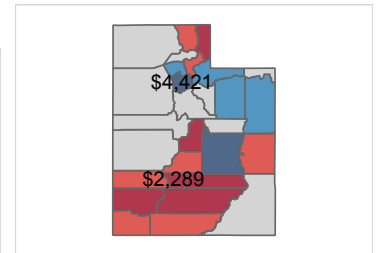
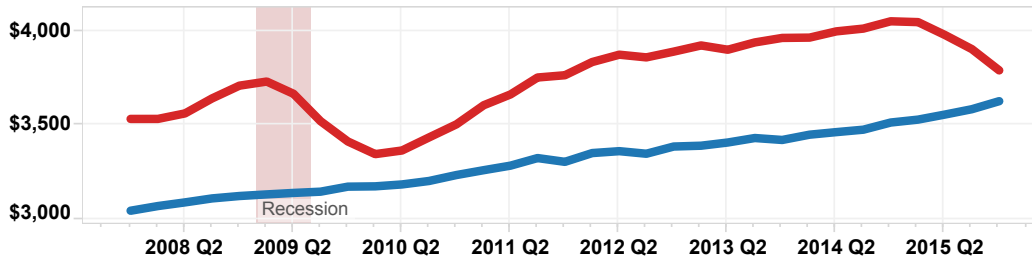

Unemployment and Wages

Uintah County's jobless rate is currently 11.5 percent and almost double the rate from a year ago.



First-time unemployment insurance claims peaked dramatically in early 2015. Less than half the current new claims were directly oil and gas related.



So far in 2016, mining, construction, and transportation tallied the highest number of claims.



Average wages began to show the inevitable drop typically associated with the loss of high-wage jobs.



Uintah County's average monthly wage declined \$114 from the third quarter to total \$3,793.

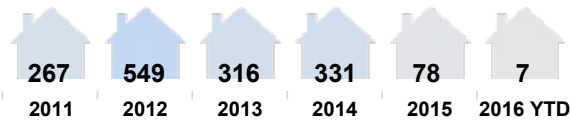

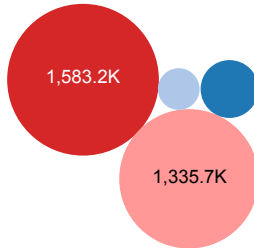
Construction Permitting JANUARY-MARCH 2016

Dwelling Unit Permits



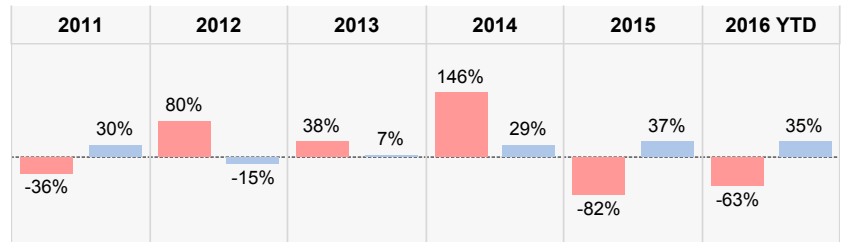

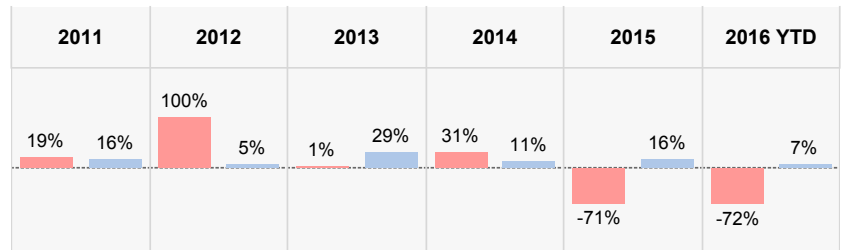

Year-to-Year Change In Gross Taxable Sales FOURTH QUARTER 2015

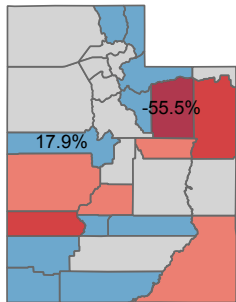

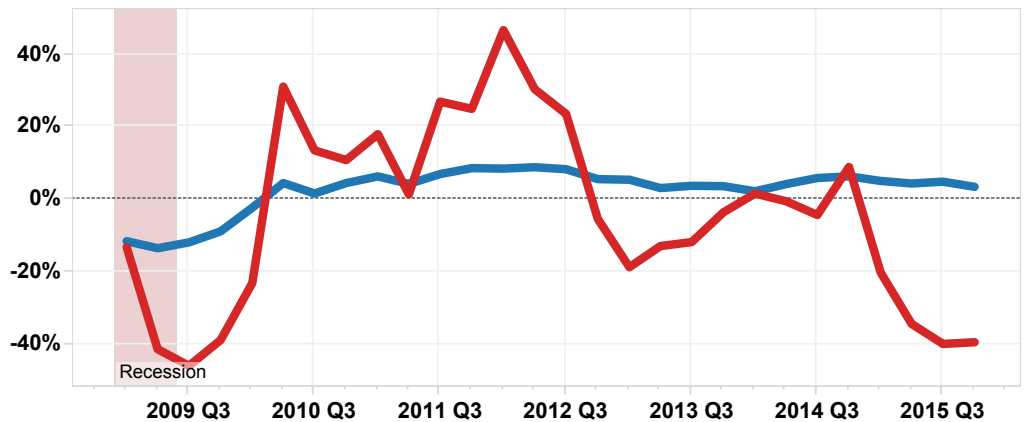

Construction and Sales

Both residential and nonresidential new construction values dropped dramatically when 2015 and 2016 are compared. The steep decline is masked by the construction of a industrial facility.

Between the fourth quarters of 2014 and 2015, Uintah County's gross taxable sales decreased by 40 percent.

The slowdown was widespread and across all the broad sectors.
